### **FREQUENTLY ASKED QUESTIONS**

#### Can I register to attend at the venue?

**YES,** \$30 two-day ticket, **CASH ONLY** The Baltimore Convention Center has multiple ATM locations on site Box office opens at 9:30am both days

### **Do I need a medical marijuana card to attend? NO.**

Are pets allowed? NO. Only registered service animals are allowed

Is there an age requirement? YES. 21+, unless accompanied by parent/guardian.

**Do I have to register my child to attend? NO.** Children accompanied by a parent do not need a ticket.

Is my ticket transferable? Yes. To transfer a ticket please email carolyn@necann.com with the name and email address of the person you'd like to transfer your ticket to.

#### What is the refund policy?

All tickets are non-refundable.

### Can I bring a bag/backpack?

**YES.** Baltimore Convention Center security reserves the right to search all bags/back-packs and may refuse any bag to be allowed in. NECANN will store rejected bags at the registration desk. Food, beverages, and weapons are not allowed in the venue, please see Baltimore Convention Center website for full details: www.bccenter.org/p/attend

#### Is this event handicap accessible? YES.

**Can I leave and re-enter? YES,** attendees may leave and re-enter as often as they wish, but MUST have their show-badge for re-admittance. You will not be allowed back in without a show-badge.

Is Cannabis use allowed onsite? NO. All Maryland laws regarding cannabis use in public are in effect; no displaying, smoking/ vaping/consuming cannabis anywhere on Baltimore Convention Center property.

**Can I take pictures/video? NO.** Videotaping of speakers/programming is not allowed in ANY speaker session. Pictures & videotaping are allowed on the exhibit floor, but you should get permission before photographing/ filming people directly. NECANN & the Baltimore Convention Center reserve the right to restrict/deny photography/video recording in any area, at any time, at their sole discretion.




